The 101st Annual Meeting of the Genealogical Society of New Jersey was held virtually on Wednesday, 16 November 2022, using the Zoom platform. President Melissa Johnson welcomed attendees to the third virtual annual meeting. She introduced Vice President Christine Murphy, who instructed attendees on using the Zoom "raise-your-hand" function, used throughout the meeting to count members and administer votes.

President Johnson opened the meeting at 7:35 P.M. and read the minutes of the 2021 Annual Meeting. After a motion and a second, the minutes were approved as read.

Annual Report of the Editorial Committee of the Genealogical Magazine of New Jersey (GMNJ)

Volume 98 (2023) of the *Genealogical Magazine of New Jersey* includes articles relating to families of Camden, Cumberland, Essex, Gloucester, Hudson, Hunterdon, Monmouth, Morris, Ocean, Somerset, and Warren counties, spanning the seventeenth through the twentieth centuries. In this volume, authors contributed Beekman, Böshaar, Browne, Burwell, Bush, Corlies, Kise, Linaberry, Lorentz, More, Staats, Thompson, Tindall, Titus, Van Nuys, Vanscoten, Voorhees, Williamson, and Woos family research. Other articles include inscriptions from the Vincent Methodist Cemetery of Nutley (Essex), Old Union Cemetery of Hope Township (Warren), and Pleasant Grove Cemetery of Jackson Township (Ocean). Other source material includes a few Bible records and the account book of a Monmouth County coffin maker.

Editorial committee members spend many hours proofreading each final draft of *GMNJ* while searching for possible errors in the narrative text, accessing online links for validity, and checking citations for content accuracy. Committee members also "blindly review" each work submitted to *GMNJ*. Without knowing the author's name, they judge every article sent to our Editor on merit, not solely on the author's reputation as a genealogical writer.

GSNJ members will have noticed the long delay in receiving issues of *GMNJ* this year. First, we transitioned to a new printing company after McNaughton & Gunn was sold to Sheridan Press. Secondly, with the retirement of Jane Fletcher Fiske at the end of 2022, GSNJ engaged in a fourmonth search for a new editor. In May 2023, we welcomed Deanna Eckman Korte as Editor of *GMNJ*.

A newly established Writers' Group for *GMNJ* started in July 2023 under the leadership of this committee and hosted by GSNJ President Melissa A. Johnson and Editor Deanna E. Korte. All GSNJ members and non-members interested in writing for *GMNJ* are invited to describe their research subjects and stumbling blocks to completing their work. At monthly meetings, two or

three hosts provide guidance and help on finding new material and encouragement to prospective writers with the promise that *GMNJ* will publish more scholarly genealogical articles.

Annual Report of the GSNJ Manuscript Committee

As Alexander Library, where the GSNJ collections are held, has been closed due to the pandemic and subsequent water damage from Hurricane Ida, Manuscript Committee activities have been curtailed. The record of usage has been irrelevant and maintenance halted. Many of the collections were moved to the New Jersey Room and others were moved off-site.

The library has re-opened but research can only be done by appointment. Library staff brings requested material to a designated location to be studied. In the case of GSNJ materials, what may be helpful is difficult to determine. I'm now allowed to access the New Jersey Room and may be able to assist. How long this situation will prevail is unknown.

Manuscripts and monographs donated to the Society are acknowledged, accessioned, and filed. The papers of Shirley Moore Barnes have been recently received, and a finding aid is being prepared. Contributions of family research are greatly appreciated.

Annual Report of the GSNJ Gravestone Committee

In 2023, the gravestone committee did not conduct any onsite tombstone hound expeditions. Older recordings of cemeteries not yet published generally involve pairs of volunteers checking the gravestones one last time. Volunteers check to see if grave markers are still present or missing, and still legible. They also transcribe newer stones added since the cemetery was last recorded. Additionally, the GSNJ cemetery collection of field notes and previously recorded inscriptions is closed until Special Collections and University Archives, Alexander Library, Rutgers University, reopens to the public.

Serialization of Vincent Methodist Cemetery concluded in January 2023 of the *Genealogical Magazine of New Jersey*. Later issues published inscriptions from the Old Union Cemetery in Hope Township, Warren County, and Pleasant Grove Cemetery, Jackson Township, Ocean County. In the meantime, this committee will continue to format older field notes from prior recordings into articles for publication by GSNJ. For several larger cemeteries, it was decided to

bypass publication in *GMNJ* and add inscriptions directly to *Find-A-Grave* (https://www.findagrave.com) using the "userid" of GSNJ Tombstone Hounds.

Annual Report of the GSNJ Corresponding Secretary

The primary responsibility of the Corresponding Secretary is to reply to requests for research information. From September 2022 through September 2023, 70 items of mail or email were received. Some of the requests used the form on the website requesting searches in multiple collections for specific individual names. Other requests were for photocopies or scans of Bible records, cemetery inscriptions, or articles published in the *Genealogical Magazine of New Jersey*. Some requests were forwarded from Rutgers University's "Ask a Librarian" to Special Collections & University Archives (SC/UA), and thence to me. Some requests come via social media and were forwarded from the GSNJ webmaster who monitors social media.

As done in the past, this is a volunteer project, carried out with assistance from another trustee, as time permits. Unfortunately, extensive research cannot be done but then the requestor is referred to the GSNJ website which identifies professional genealogists, or a recommendation is made of another possible source of the requested information. It is suggested that mail inquiries for research include a self-addressed, stamped envelope to expedite a reply. When one is not present and an email address is provided, an email reply is sent. Many requests are answered by email with attachments.

The temporary relocation of the Bible and Family Records Collection and the Gravestone Inscriptions Collection to the NJ State Archives to permit access and increased scanning has helped greatly. Requests for articles from the magazine have been completed and I am now permitted in the NJ Room one morning a week to search the collections there for requestors.

Annual Report of the GSNJ Program Committee

GSNJ hosted two programs in the past year: the 2022 Annual Meeting and the 2023 Spring Conference. GSNJ 100th Annual Meeting was held virtually on Wednesday, 16 November 2022. The event was free and open to the public. The meeting was followed by the monthly webinar series.

The 2023 GSNJ Spring Conference was held on Saturday, 22 April 2023 as an in-person program. Eight lectures were presented as part of two tracks. The program consisted of the following lectures: Using Autosomal DNA for 18th and 19th Century Mysteries, The Miracles and Sins of Church and Cemetery Records, Are You Doing Everything to Identify Your DNA Matches?, Using Probate and Estate Records to Raise the Dead, The Danger of Distant Matches, Learn How to Find and Plat Your Ancestor's Land, The Helen Marley Story, and Finding Treasures in Military Records. Door prizes were awarded. Surveys about the speakers and the event were collected from attendees.

The GSNJ Webinar Series – "Your Roots Pursuits" continued in 2023. Webinars were scheduled monthly with various topics each month, including: What is WikiTree?, Genealogical Writing with Q&A about Publishing in GMNJ, Whether the Weather: How Weather Affected Our Ancestors, The Dutch Reformed Churches in America, She Came from Nowhere: A Case Study Approach to a Difficult Genealogical Problem, Weird Things I Have Inherited and How to PreserveThem, Finding Our Ancestors by Researching the Neighbors, American Military Records of the 18th and 19th Centjury, African-American Genealogy: Strategies for Researching, Genealogy in the 21st Century: Using DNA to Aid Your Paper Research, Finding Records on FamilySearch, and 10 Common Lineage Society Application Mistakes—and How to Avoid Them.

GSNJ's members-only virtual programs continued in 2023. Office Hours are held on the third Monday of the month at 7:30 p.m. This program allows members to come and ask questions of the Trustees. Noontime Knowledge is held on the third Monday of the month at 1:00 p.m. A topic related to New Jersey genealogy is discussed. These two programs alternate months and are each presented six times a year.
